## **Inaugural Session**

#### Pou Sothirak



Ambassador Pou Sothirak is a Cambodian academic and former politician. He is currently serving as the executive director at the Cambodian Center for Cooperation and Peace. Between 1993 and 1998, he was the Cambodian Minister for Industry, Mines and Energy. He is a former member of the royalist FUNCINPEC and was elected to represent Siem Reap Province in the National

Assembly in 2003. Sothirak served as Cambodia's ambassador to Japan between 2005 and 2009.

#### Mohan Kumar



Ambassador (Dr.) Mohan Kumar is the Chairman of Research and Information System for Developing Countries (RIS) since June 2018. Ambassador Kumar has had an outstanding career in the Indian Foreign Service lasting 36 years which culminated in his posting as India's Ambassador to France based in Paris. Ambassador Kumar is a francophone and a Francophile. The strategic partnership between India and France grew remarkably under his watch

in areas as diverse as defence, space, nuclear and solar energy, investment and culture. He was also actively involved in the Climate Change Accord of Paris in 2015. Prior to this, he was India's Ambassador to the Kingdom of Bahrain where he was witness to the momentous events of the "Arab Spring".

Professor Sachin Chaturvedi has been part of several important initiatives of the Government of India and takes keen interest in transforming economic policymaking towards integrated and evidence based approaches. He is one of the foremost commentators on India's external sector economic engagements and partnerships. He is considered as most dynamic and affable by his peers and has mentored several bright scholars and researchers in the profession.

He has authored/edited more than 20 books, apart from contributing several chapters in the edited volumes and also publishing several research articles in prestigious journals. He is on the Editorial Board of several journals including the South Asian Economic Journal, IDS Bulletin, Sussex, UK among others. His book "The Logic of Sharing – Indian Approach to South-South Cooperation" has been acclaimed internationally as one of the best volumes on international development cooperation. # Kung Phoak



H.E. Dr Kung Phoak is appointed as Secretary of State at the Ministry of Foreign Affairs and International Cooperation on 23 October 2021, overseeing works related to ASEAN Economic Community (AEC) and ASEAN Socio-Cultural Community (ASCC). H.E. Dr Kung is Cambodia's High-Level Representative for the ASEAN Community's Post-2025 Vision, and he also serves as the

Head of the Office of the Special Envoy of the ASEAN Chair on Myanmar for 2022.

Before assuming his current role, H.E. Dr Kung served as Deputy Secretary-General (DSG) of ASEAN for ASEAN Socio-Cultural Community (ASCC) from 2018 to 2021. He supported the Secretary-General of ASEAN by providing leadership in implementing the ASCC Blueprint and led the ASCC Department of the ASEAN Secretariat.

Prior to joining ASEAN Secretariat, H.E. Dr Kung was the Undersecretary of State at the Office of the Council of Ministers of the Royal Government of Cambodia and was working on foreign policy in the Office of the Prime Minister of the Kingdom of Cambodia.

H.E. Dr Kung did his PhD study in political science and international relations at the University of Warwick, United Kingdom. He obtained Master's degree in Public Policy specializing in Economic Policy and Graduate Diploma in Public Administration at Australian National University. He also obtained a Bachelor's degree in Industrial and Mechanical Engineering at the Institut de Technologie du Cambodge. He has written and published extensively on foreign policy, defense policy, national politics, and international trade.

# Rajkumar Ranjan Singh



Dr. Rajkumar Ranjan Singh is currently serving as the Minister of State, External Affairs Minister of India. was born on 1st September, 1952 at Kongba Nandeibam Leikai, Imphal East, Manipur. He was sworn in as a Union Minister of State by the President of India on 7th July 2021. He officially took charge as Minister of State for External Affairs and Education on 8th July 2021.

Dr. Singh is a Post Graduate in Geography and earned his Ph. D. from Gauhati University. He served in different capacities including as a Lecturer, Assistant Professor, Deputy Registrar and Registrar. He also served as Director in-charge of the UGC Academic Staff College and College Development Director of Manipur University till his superannuation in 2012. He was a Senior Visiting Fellow in the Department of Geography in Manipur University, until he joined electoral politics in 2013. He has published 8 books and made numerous contributions to various national and international journals, and publications. During his academic career, Dr. Singh also participated in several national and international consultative meetings on Human Resource Management, Security Sector Reforms and Land and Livelihood Rights of Indigenous Peoples.

# Session V: Way Forward: Towards the Fourth Decade and Onward of ASEAN-India Relations

## **Bradley Murg**

Murg is Provost and Vice-Rector for Academic Affairs, Paragon International University (Phnom Penh); Associate Professor and Chair, Department of International Relations and Political Science, Paragon International University and Distinguished Research Fellow, Royal University of Law and Economics, Phnom

His work, supported by grants from the Social Science Research Council and the International Research and Exchanges Board, focuses on contemporary international relations in Southeast Asia; the political economy of foreign aid; and the politics of the Greater Mekong Subregion as a whole. Dr Murg graduated Phi Beta Kappa from Emory University with a B.A./M.A. in philosophy, received a M.Sc. in economic history from the London School of Economics, and his M.A. and Ph.D. in political science from the University of Washington. ## Valedictory Address

## Jayant N. Khobragade



Amb Jayant Khobragade is a member of the Indian Foreign Service. He is currently serving as Ambassador to the Indian Mission in ASEAN, posted in Jakarta. He previously held diplomatic assignments including in Russia, Kazakhstan and Spain. He was India's Ambassador to the Kyrgyz Republic since August 2013 for three and a half years. He also worked in the different Divisions of the Ministry of External Affairs including the Disarmament and International Security Affairs.

## **Concept Note**

- 1. The ASEAN-India relations have made substantial progress in last two decades. India's engagements with Southeast and East Asia have received new momentum under the Act East Policy (AEP). India's relations with ASEAN have grown rapidly from a sectoral dialogue partnership in 1992 to a full dialogue partnership in December 1995 to the summit partnership in 2002. ASEAN and India are going to celebrate the 30 years of dialogue relations in 2022.
- 2. The relationship between them has been further strengthened with the ASEAN-India FTA in goods and some other initiatives such as agreement for services trade and investment and connectivity projects, etc. The relationship is set to deepen as ASEAN and India step up their collaboration across a range of economic and strategic issues, including trade and connectivity, people-to-people links, maritime security, among others. While prospects for India's trade with Southeast Asia have grown rapidly, challenges too have multiplied. With ASEAN and India working towards establishing Indo-Pacific, their cooperation will be the key to economic stability, competitiveness, growth and integration in the region.
- 3. The Covid-19 pandemic is in its third year and the new variants are posing many new challenges to the economic recovery process. The importance of achieving 100 per cent vaccination and proper testing and surveillance measures has ratcheted up. This provides an opportunity for ASEAN and India to share vaccine support and best practices to contain the virus. With the global economic landscape shift brought by digital revolution, ASEAN and India together have to explore new sources of growth and avenues to strengthen the partnership. Southeast Asia branches out as a digital hub with increasing population using internet and mobile phones. As much as 98 per cent of the business in ASEAN is driven by SMEs. The enmeshing of digital technology can provide new business strategies and solutions. India is also marked by such digital trends. Thus, it will be imperative for ASEAN and India to come together in roping the small businesses, harnessing their potential in leading the recovery following the pandemic. What follows is that ASEAN and India shall enhance collaboration in order to address common and emerging challenges, particularly in view of Covid-19 pandemic 2 and changing global order. Among other measures, new ideas and an actionable set of

recommendations may lead to strengthening the relationship further. This calls for a stronger network of think-tanks between ASEAN and India.

- 4. The increasing complexity of the global challenges make it imperative to run and mobilize an effective network of institutions, media and business houses involved in the policy dialogue, which can generate useful documents for policy makers to make informed decisions. Think-tanks generate new ideas in formulating public policy. They make significant contributions in shaping the future discourse of our leadership. The ASEAN-India Network of Think-Tanks (AINTT), as an initiative, has successfully enabled our academic community in the region to come together, on a common platform for exchange of views. The last six roundtables of AINTT were held at New Delhi (2012), Vientiane (2013), Hanoi (2014), Kuala Lumpur (2015), Jakarta (2018), Bangkok (2020), respectively. While the first five roundtables were held in physical mode, the sixth roundtable was held in virtual mode. The last six rounds of the AINTT made important contributions towards policy decisions by the ASEAN countries and India, thereby further strengthening the ASEAN-India partnership. Besides, a rich set of literature on ASEAN-India relations was produced from each of these roundtables. Based on the recommendation of the 6th AINTT roundtable, the ASEAN-India Centre (AIC) at RIS has decided to organise the 7th AINTT roundtable in virtual mode in May 2022. The 7th AINTT roundtable will be supported by the Ministry of External Affairs (MEA), Government of India. The Cambodian Institute for Cooperation and Peace (CICP), Phnom Penh will be the ASEAN host and co-partner.
- 5. Given above, the broad objectives of the 7th AINTT roundtable are primarily two-fold: First, to identify emerging challenges to ASEAN-India relations through interaction among prominent think-tanks; and Second, to identify the feasible policy options to overcome the challenges from the perspective of ASEAN-India partnership. In general, the seventh edition of the AINTT will make an attempt to discuss the regional cooperation agenda for ASEAN-India partnership in the post Covid-19 period. In particular, the roundtable will discuss the newer challenges that the ASEAN-India region has been facing and present the scope and opportunities for regional cooperation in view of the emerging global situation. The sessions matching with aforesaid objectives are identified as follows: Session I: Economic and Sustainable Recovery: This session will enable discussion on the

prevailing global order and will provide a platform to devise new strategies for a renewed role of ASEAN and India in constructing a sustainable society post the Covid-19 pandemic. Session II: Cooperation in Health: This session will connect participants to some important issues in the developing world of procurement of vaccines and sharing an online portal for monitoring. Discussion on strategies to mitigate these issues would prove beneficial for the region as a whole in coming back to economic track. Session III: SDG Implementation and MSMEs Participation: This session will deliver new avenues of collaborative activities and exercises for discussing a collective path to the SDGs. Though significant progress has been shown on the 17 SDG goals, ASEAN countries and India 3 display a stark contrast. The session will enable discussions on the role of Micro, Small and Medium Enterprises (MSMEs) in attaining the SDGs given their increasing presence in both ASEAN and India. Session IV: Connectivity and Supply Chain Response: Strengthening value chains between India and ASEAN countries in the ongoing pandemic has gained high importance in bilateral relations. This session will present the connectivity and supply chain response in the post Covid-19 period. Session V: Way Forward: Towards the third decade and Onward of ASEAN-India Partnership: This session will review the past and suggest ways to further strengthen the partnership in the third decade of ASEAN-India partnership. This session will host a panel discussion with key/lead panelists of the 7th AINTT. It will draw a set of actionable projects and also guide us about the next course of AINTT.

- 6. Resource persons from ASEAN countries, India, and ASEAN Secretariat will be invited to attend the roundtable. AIC and CICP will make all arrangements for their participation through virtual / hybrid mode.
- 7. Cambodia being the ASEAN Chair, senior leaders of Cambodia and India may likely address the aforesaid roundtable. Besides, ASEAN Secretary General and Secretary (East) in the Ministry of External Affairs (MEA) will be invited to deliver a Special Address. Indian Ambassador to Cambodia, Indian Ambassador to ASEAN, Senior officials of the governments of India, Cambodia, remaining AMS and ASEAN Secretariat will attend the 7th AINTT roundtable. The proceedings of the 6th AINTT roundtable will also be released/distributed at the 7th edition of the AINTT roundtable.

8. The 7<sup>th</sup> edition of the AINTT roundtable will be coordinated by Dr. Prabir De, Coordinator, AIC, New Delhi from Indian side and Ambassador Pou Sothirak, Executive Director, CICP, Phnom Penh from Cambodia side. Participants of each technical session will be invited to present a research paper at the roundtable. Subsequently, these papers would be expanded/revised and distributed amongst the policymakers and other concerned stakeholders either in the form of working paper or compiled volume. AIC and CICP jointly will also publish the proceedings of the roundtable.

## **About the AINTT**

The increasing complexity of the global economic environment makes it imperative to establish an effective network of institutions, media and business houses involved in the policy dialogue, which can generate considered documents for policymakers to take informed decisions. With the Free Trade agreement (FTA) between India and the ASEAN effective from 1 January 2010, India-ASEAN partnership has taken a new shape. In 2022, the ASEAN and India celebrate their 30 years of dialogue relation and 20 years of summit-level interaction.

India's engagement with the ASEAN is at the "heart" of its Act East Policy. We are convinced that India's future and our economic interests are best served by greater integration with our Asian partners. The implementation of the ASEAN-India FTA in 2010 has opened up new vistas of trade cooperation between the two partners. With both sides showing active interest to deepen and widen process of economic integration through agreements on services, investment, etc., there would be an increasing array of issues on culture, connectivity and commerce, which need to be addressed to strengthen partnership between India and the ASEAN. Deliberations between these organisations would help provide well -considered policy inputs to the governments.



To realise this objective, policy dialogue among relevant institutions, media and business community from India and the ASEAN assumes utmost importance. These deliberations would not only help in promoting awareness about the potential of the India-ASEAN partnership, but would also help in exploring new vistas for strengthening regional cooperation.

The Roundtable of the ASEAN-India Network of Think-Tanks (AINTT) is an outcome of Indian Prime Minister's Statement at the 7th India-ASEAN Summit, where he suggested establishment of an India-ASEAN Roundtable, comprising think-tanks to bridge knowledge gap. The objectives of these Roundtables have been to promote awareness about the current status and potential of the ASEAN-


India Partnership and provide long-term perspectives on the development of ASEAN-India relations. The interaction among Think-Tanks would also deepen the ASEAN-India economic partnership through policy research and advocacy. Another purpose of the interaction between think-tanks is to deepen the ASEAN-India partnership through policy research and advocacy. The RIS envisages this forum as high-quality research platform for the policymakers, academics, professionals, and the research communities. The last six roundtables of the AINTT were held at New Delhi (2012), Vientiane (2013), Hanoi (2014), Kuala Lumpur (2015), Jakarta (2018) and Bangkok (2020) respectively. The RIS has been involved in interacting with think-tanks, particularly from the ASEAN region, for a number of years. The first major initiative in this regard was the International Conference that RIS organized in 2004 on ASEAN-India Vision 2020 at New Delhi on behalf of the ASEAN India Network of Think-Tanks (AINTT).

The AINTT was formed following a decision taken by the Leaders of the ASEAN and India at their First Summit, held in November 2002. Besides coordinating with think-tanks as a part of the India-ASEAN engagement, the RIS is also actively involved in several other think-tank networks. These include Economic Research Institute for ASEAN and East Asia (ERIA); Asia Pacific Research and Training Network on Trade (ARTNeT), coordinated by UNESCAP; and BIMSTEC Network of Policy Think-Tanks, among others. The AINTT Secretariat is located at the ASEAN-India Centre (AIC) at the RIS. 


