### Postponement of MC12 Leaves Scope for More Work

By the time the webinar took off, postponement of MC12 due to Omicron spread was already announced. But speakers stressed that India should use postponement of WTO Ministerial to connect with South. Developing countries should analyse the impact of postponement of the WTO Ministerial Conference (MC12) on the outcome of the event and use the time till it is convened again to protect their interests by staying united and consolidating their positions, according to international trade experts from the Global South. The decision on the postponement of the MC12 (slated for November 30-December 3, 2021) was taken late Friday by the WTO General Council "after an outbreak of a particularly transmissible strain of the COVID-19 virus."

Speaking at the webinar, Professor Carlos Correa, Executive Director, South Centre, Geneva, said the developing country think tanks like the South Centre and RIS should analyse all the proposals and ensure that the postponement of the MC12 will help consolidate developing country positions on various issues including fisheries subsidies, agriculture, TRIPS waiver and Special and Differential Treatment.

Referring to the WTDR's focus on how technology and trade are impacting each other, Prof Correa said this issue, though very important especially in the post-COVID scenario that saw acceleration of digitalization, has not been dealt with seriously at the WTO.

Dr Mohan Kumar, Chairman, RIS, said developing countries need to get their act together by looking at the opportunities and challenges that have emerged due to the postponement of MC12. Ensuring 'success of the MC12 at any cost' should not mean that 'success' is cornered by the developed world and developing countries are left to bear the 'costs', he said.

Ambassador Jayant Dasgupta, formerly India's Ambassador to WTO, said the postponement of the MC12 gives an opportunity to developing countries to prepare strongly to counter some proposals which are against their interests. He said developed countries will have to come clean on issues such as sustainability and gender through which they have been indirectly trying to gain market access in the developing world.

Dr Nagesh Kumar, Director, Institute for Studies in Industrial Development (ISID), referred to the importance of the proposal on TRIPS waiver by India and South Africa and said that the WTO should demonstrate that protection of the lives of billions of poor people in the developing world is more important than protection of the bottom line of a few MNCs that have developed COVID vaccines, diagnostic kits and drugs. He said the discussion on investment facilitation for development should ensure a balance in the rights and responsibilities of investors, home country and host country. He said major developing countries like India should be a part of the plurilaterals including on investment facilitation so that they can ensure that their outcome is not against developing country interests.

Professor Sachin Chaturvedi, Director General, RIS, said it is all the more important to strengthen developing country coalitions and ensure that the Global South remains as a cohesive unit on various MC12 issues including on the Joint Statement Initiatives to ensure that they do not take away the

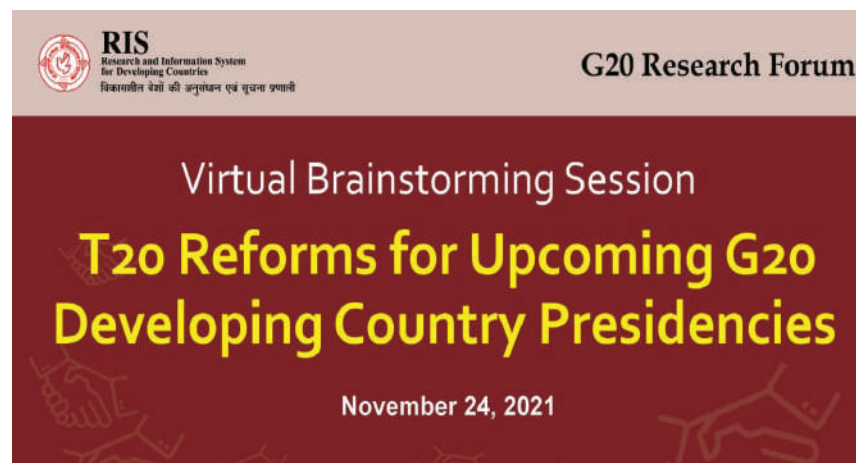

### T20 Should have Greater Representation from the Developing World: Researchers

The Think20 - one of the important Engagement Groups of the G20 comprising the 20 leading global economies - should have greater representation from developing country think-tanks, and must bring out their policy recommendations on global governance issues well in time for the G20 leaders to analyse and incorporate them in their final Declaration, according to researchers from across the world. This assumes importance as major developing countries Indonesia, India, Brazil and South Africa are slated to assume G20 Presidency in 2022, 2023, 2024 and 2025 respectively. The expectation is that the development agenda will now be at the front and centre of the discussions by G20 and its Engagement Groups including Business 20, Think 20, Women 20, Youth20, Labour 20, Urban 20, Civil 20 and Science 20. There are now calls for greater representation and voice from developing economies to make the processes more inclusive.

Speaking at a virtual Brainstorming Session on 'T20 Reforms for Upcoming G20 Developing Country Presidencies' organized by the RIS on 24 November 2021, Professor Bambang Brodjonegoro, lead Co-Chair, T20 Indonesia and former Minister of Finance of Indonesia, said Indonesia is looking to ensure proportionate representation from all the continent and countries of all income groups. He added that issues such as cooperation in international taxation, infrastructure financing, SDGs, digitalization and revival of multilateralism are of great importance to developing and developed countries, and therefore



should be accorded continuity in the T20 process for their effective implementation by the G20 Members. He said issues such as poverty and income inequality as well as sustainable financing of the Sustainable Development Agenda will be given priority during the Indonesian G20 Presidency.

Prof. Djisman Simandjuntak, lead Co-Chair, T20 Indonesia, said with a view to get innovative policy ideas, Indonesia will be reaching out to African think-tanks and will consider Policy Briefs from think-tanks and researchers who have not had the chance to participate in the T20 process so far. Ms. Elizabeth Sidiropoulos, Chief Executive, South African Institute of International Affairs, South Africa, mentioned about 'T20 Africa Standing Group' as important interlocutor and part of the T20 process from now on. Ms. Anita Prakash, Senior Policy Advisor (Int. Economic Relations), ERIA, Jakarta, briefed the participants about the newly launched the G20 Research Forum by ERIA, RIS and 'LPEM-FEB IU' of Indonesia to collate ideas from various think-tanks and researchers on global governance issues. Dr. Imme Scholz, Deputy Director, German Development

Institute (DIE), Germany, referred to the way T20 Germany was organised and some tips to Indonesia and India. She also mentioned that Germany going to hold the G7 Presidency in 2022 and sought a mechanism for close collaboration with Indonesia (G20 Presidency for 2022) on various issues. She said this G7-G20 (and their Engagement Groups) coordination mechanism should be made applicable to all G20 events.

Others who spoke on the occasion included Prof. Sachin Chaturvedi, Director General, RIS, Prof. Naoyuki Yoshino, Professor Emeritus (Economics), Keio University, Japan, Ms. Gala Díaz Langou, Executive Director, CIPPEC, Argentina, Dr. Antonio Villafranca, Research Director, Italian Institute for International Political Studies (ISPI), Italy, Dr. Riatu Mariatul Qibthiyyah, Director, LPEM, University of Indonesia, Dr. Yose Rizal Damuri, Head, Department of Economics, Centre for Strategic and International Studies, Jakarta, Dr. Nicolas Buchoud, Grand Alliance, Paris, Dr. Priyadarshi Dash, Associate Professor, RIS, and Mr. Augustine Peter, Visiting Fellow, RIS. ■

## BRICS Needs to Strengthen Efforts for Reform of Multilateral Institutions

The BRICS countries will continue their efforts to strengthen and reform multilateral institutions including the UN and IMF, in addition to enhancing cooperation in important areas such as counter-terrorism, 'green and digital' transition, as well as 'Science, Technology and Innovation' (STI), according to Ambassador Sanjay Bhattacharyya, Secretary (CPV & OIA), Ministry of External Affairs and India's BRICS Sherpa.

Speaking at the 'BRICS Virtual Economic Conclave 2021' hosted by the RIS in collaboration with the Ministry of Finance and the RBI on 26 November 2021, Ambassador Bhattacharyya said the three pillars of BRICS engagement are: 'reform' of structures within BRICS and at the multilateral level;

'consolidation' of the work that BRICS countries have done so far; and 'future orientation' through STI as well as ensuring that the 'green and digital' transition on the basis of the 'Access, Equity and Inclusion' principle. He also stressed that 'The five major emerging economies will also enhance cooperation on counter-terrorism, 'green and digital' transition, and STI.'

He said the focus on counter-terrorism is important as "peace and stability form the basis for development". The demand for reforms of multilateral institutions including the UN and IMF was due to the existing system being unable to deal with the present day challenges, particularly those being faced by the developing world. Since the BRICS countries

are among the largest developing economies of the world, actions taken by these five countries can form a template for the rest of the world, and especially the Global South, to follow, he said.

Dr. Krishnamurthy Subramanian, Chief Economic Advisor, Ministry of Finance, dwelt on the importance of ensuring economic recovery from the global crisis. He said India studied and addressed supply side shocks for staging a recovery through reforms by effectively dealing with supply side frictions. In this process, India also focused on capital expenditure to create productive assets including resilient and sustainable social infrastructure in education and health sectors, he said. He emphasized that BRICS

## 38th STIP Forum Lecture

The 38th STIP Forum Lecture was delivered by Prof. Dipankar Banerjee, Director, Aryabhata Research Institute of Observational Sciences (ARIES) Nainital, Uttarakhand on 29 October 2021 via online platform. The topic of this public lecture was "Growth of Solar Physics in India from Ground and Space-based Platforms". The event was chaired by Prof. Arnab Rai Choudhuri, Department of Physics, IISc, Bengaluru. Dr. Nakul Parashar, Director, Vigyan Prasar, delivered the welcome remarks.

In his very insightful address, Prof. Dipankar Banerjee provided an overview of the status and prospect of solar physics in India. He began his lecture by giving a detailed overview of the solar facilities existing at various places across the country and explained the technical nuances of the subject. He talked about sophisticated instruments such as Multi Application Solar Telescope, which is needed to study the variability of different timescale in the Sun, sunspots, solar flares and

so on. Prof. Banerjee elaborated on the proposed National Large Solar Telescope (NLST) which will be 2m class optical and near infra-red (IR) observational facility in the country. It is designed to address an array of key scientific issues related to origin and dynamics of solar magnetic fields at a spatial resolution of 0.1-0.3 arc-second. The instrument has a broad scope to support and substantiate the multitude of solar atmospheric observations from space-based mission and ground based MAST telescope (Udaipur).

Prof. Banerjee further mentioned about the upcoming India's first space-based mission to study the Sun, Aditya L1. It is a multi-institutional mission led by ISRO and is expected to be launched sometime in mid-2022. The seven payloads (instruments) will study solar corona, solar emissions, solar winds and flares, Coronal Mass Ejections (CMEs), as well as capture images of the Sun. This project will enable a comprehensive understanding of the dynamical

processes of the sun and address some of the outstanding problems in solar physics.

At the end, Prof. Banerjee talked about the role of his institution, ARIES, in training the next-generation of solar scientists/physicists in India. Aditya-L1 Support Cell (AL1SC) has been established at the Aryabhata Research Institute of Observational Sciences (ARIES), which will primarily produce the required trained manpower. An MoU in this regard was inked between ARIES and Indian Space Research Organisation (ISRO) earlier this year. The Support Cell will be a one-stop online platform for students, faculty and researchers from colleges, universities and institutions in India to get free access to a sample of processed scientific data pertaining to the Sun. All the data will be hosted at the Indian Space Science Data Centre (ISSDC) of ISRO with ARIES Cell acting as a manpower training centre. ■

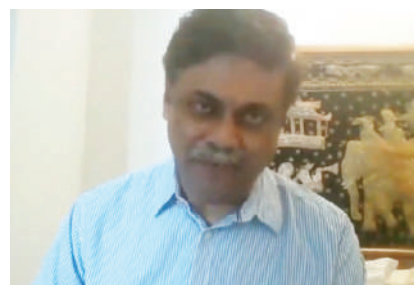
#### Panel Discussion on 'Future Strategies for SIDS and Climate Change: Looking through the Lens of South-South Cooperation Practice'

It was aimed to analyse climate change vulnerability and potential use of South-South Cooperation practices and experiences to take care of the threats to SIDS existence. Dr Eberhard H. Weber, the University of the South Pacific, Fiji Islands and Ambassador Vinod Kumar participated in the discussion and shared their ideas on subject. They explained how climate change is posing serious challenges to SIDS and these nations do not have resources to effectively adapt and mitigate the challenges. It was noted that global cooperation is essential

### Pandemics and New Frontiers of South-South Cooperation

The Forum for Indian Development Cooperation (FIDC), RIS organised a panel discussion, as part of its monthly seminar series, on the topic 'Pandemics and New Frontiers of South-South Cooperation' on 18th October 2021. The lecture was given by Professor Dan Banik, Director, The Oslo SDG Initiative with initial remarks by Professor Sachin Chaturvedi, Director General, RIS and special remarks

by Dr Ruchita Beri, Senior Research Associate, Coordinator, Africa, LAC & UN, Institute for Defence Studies and Analysis. The discussion was moderated by Professor Anuradha Chenoy, Former Professor, Jawaharlal Nehru University.

The discussion was organised to shed light on the status of Agenda 2030 and how the situation has worsened due

to the ongoing COVID-19 pandemic. COVID-19 pandemic has reversed development milestones of countries in terms of many economic and social crises. Professor Banik highlighted the idea of politics of development and urged to think solutions beyond the 2030 Agenda. The role of South-South Cooperation and Triangular Cooperation was also emphasised as an essential to meet the SDGs. ■

## COP-26

### Issues and Challenges during the Run-up to and at COP 26 – Indian Perspectives

Recognizing the growing concerns on climate change and its impact, and the significance of the upcoming COP 26, Vijnana Bharti (Vibha) and RIS jointly organized the webinar on 'Issues and Challenges during the Run-Up to and at COP 26 – Indian Perspectives' on 24 October 2021.

Dr J. R. Bhatt, Advisor (Climate Change), Ministry of Environment, Forest and Climate Change, Government of India was invited to deliver his insights on the Indian perspectives concerning issues and challenges in the run up to and at COP 26. Prof Sachin Chaturvedi, Director General, RIS; Ambassador Bhaskar Balakrishnan, Science Diplomacy Fellow, RIS and Former Ambassador of India; Dr Laxman Singh Rathore, Former Director General, India Meteorological Department and Permanent Representative of India at the World Meteorological Organization, and Shri Jayant Sahasrabudhe, National Organizing Secretary, Vijnana Bharti were invited to share their expert views on the theme.

In his presentation, Dr Bhatt discussed the warning signs of climate changes, timeline of climatic conventions, governance frameworks, and narratives

associated with the climate change. He noted that India has a right to fair share. India will not exceed its fair share of global carbon budget, but cannot compensate for over-consumption by others. The developed countries must declare the time of net zero in keeping with their fair share of the remaining carbon budget. They must provide carbon space to the developing countries through negative emission to compensate historic carbon debt. India's contribution to current temperature increase is very low. However, there is a high level of future climate risk. Therefore, sectors like agriculture (including livestock and fisheries), rural livelihoods, forest and biodiversity, informal and MSME sectors need time to adapt to climate change. India has been making extensive efforts to combat climate change. Dr Bhatt discussed some of the initiatives like the launch of Coalition for Disaster Resilient Infrastructure (CDRI). India co-leads the Leadership Group on Industry Transition with Sweden for hard-to-abate sectors.

Professor Sachin Chaturvedi discussed the issue of finance in climate action. He noted that about 71 per cent of climate finance

provided by developed countries are in the form of loans, which are mostly given on market rates. Given the huge gap with OECD countries, there is a greater need for South-South cooperation. Ambassador Bhaskar Balakrishnan recognized the need for net zero emission target for the world as a whole. However, he underlines that developed countries should achieve the target before the developing countries, and also set a target for negative emissions. For developing countries, the net zero emission target should be flexible. India should work with other countries to oppose any binding commitment, while making continued efforts towards the target, provided technology, finance and other large scale incentive measures are given. Dr Laxman Singh Rathore highlighted that the climate change is a global collective problem, and it requires global and collective efforts and actions. Role of NGOs and collaboration between diverse stakeholders will be important. In his concluding remarks, Shri Jayant Sahasrabudhe emphasised on the significance of collective efforts towards mitigating climate change. The vote of thanks was given by Avinash Rayarikar. ■

### First India-Korea 2+2 Bilateral Dialogue

RIS, Indian Council of World Affairs (ICWA) and Korean National Diplomatic Academy (KNDA) and Korea Institute for International Economic Policy (KIEP) of the Republic of Korea organised the First India-Korea 2+2 Bilateral Dialogue on Reimagining India-Korea Relations in the Emerging Regional Order: Synergising the 'Act East Policy' and the 'New Southern Policy' on 27 October 2021 virtually.

Programme began with Inaugural Session. Ambassador Vijay Thakur Singh, Director General, ICWA; Professor Sachin Chaturvedi, Director General, RIS; Dr. Hong Hyunik, Chancellor, KNDA; Dr. Kim Heungchong, President, KIEP; Ambassador Chang Jae-bok, South Korean Ambassador to India; and Ambassador Sripriya Ranganathan, Indian Ambassador to Republic of Korea addressed the dialogue.

Ambassador Nalin Surie, Distinguished Fellow, Delhi Policy Group chaired the Session on India-Korea Relations in a Changing Global and Regional Context: Strategic Perspectives. Speakers included, Dr. Cho Wondeuk, Research Professor, KNDA; and Dr. Jagannath Panda, Research Fellow, Manohar Parrikar Institute for Defence Studies and Analyses, New Delhi (MP-IDSA). Dr. Jojin V. 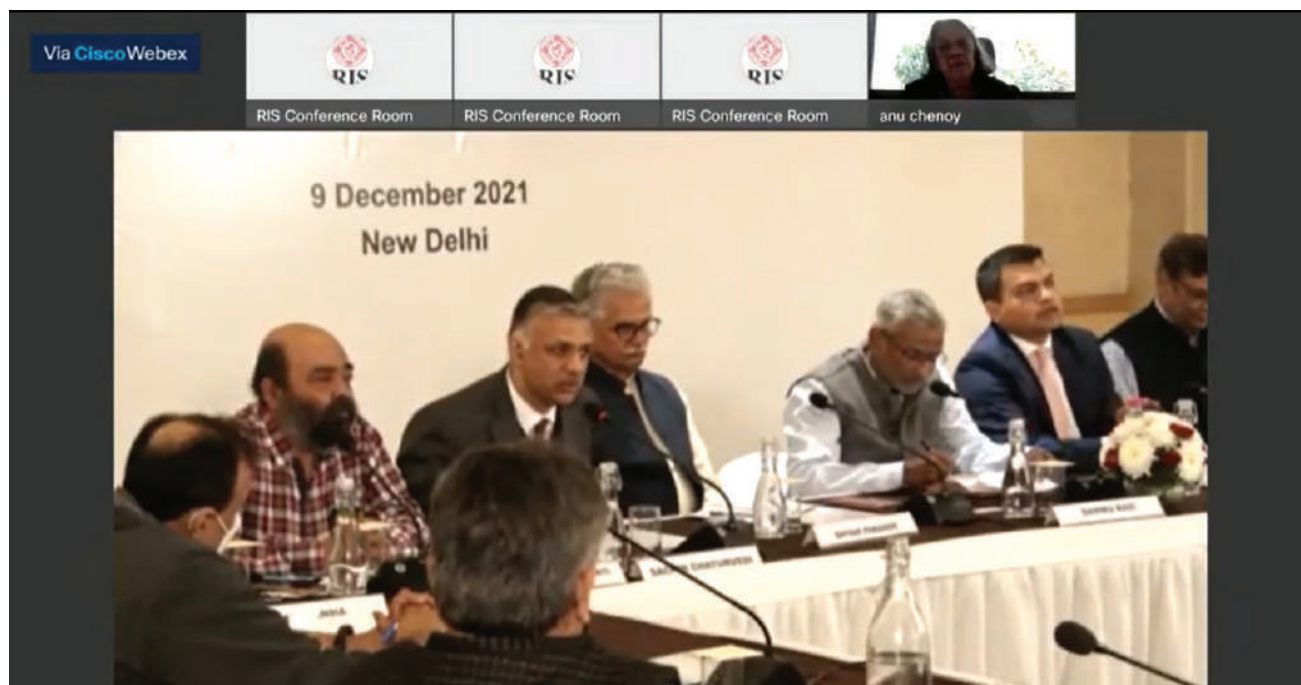
policy space of developing country governments in taking decisions in national interest. He said trade should be a catalyst for domestic production and domestic growth and not just

#### Roundtable on India-Africa Relations in a Post-Pandemic World

RIS, in collaboration with University of Oslo, Norway organised a roundtable discussion on “India-Africa Relations in a Post-Pandemic World” in hybrid mode on 9 December 2021. The purpose of the roundtable was to examine the future of India-Africa relations spread across two sessions on overall foreign policy orientations and sectoral cooperation in the areas of health, IT, renewable energy, capacity building, traditional medicine, etc.

In his welcome remarks, Professor Sachin Chaturvedi, Director General, RIS highlighted the major milestones in India-Africa relations as well as recent trends in their development partnership. He noted that India is today more keen in timely implementation of development and infrastructure projects. Prime Minister Modi has taken initiative to monitoring the progress. He also suggested to set up India’s development agency for facilitating development

cooperation in Africa and other regions. Professor Dan Banik, University of Oslo, Norway, said that there is a big departure from India’s past policy towards Africa. There are more high profile visits in recent times. Defence cooperation between India and Africa is also evolving. He noted that there is an element of shift from idealism to pragmatism in the Indian foreign policy.

In his special remarks, Shri Dammu Ravi, Secretary (ER), Ministry of External Affairs, India noted that cooperation with Africa is always important for India. Underlining India’s historical relations with Africa, Shri Ravi noted that currently New Delhi is widening its cooperation in health, renewable and IT- financial technology sectors. Apart from COVID vaccines, India provided medical assistance to African nations and is also ready to support in the future as well. He opined that there is also scope for deepening

India’s relations with Africa in telemedicine. Trade is not up to mark with Africa. Today, Africa wants to make manufactured goods not just only export of the raw materials. Therefore, India would like to set up manufacturing zones there with support of African nations. Shri Ravi said that India is exploring prospects for tri-angular cooperation with France and Britain in Africa.

India-Africa cooperation in areas of health and fintech has been extensively explored in the roundtable discussion. Panellists also noted that agriculture sector also offers opportunities for cooperation between India and Africa.

It was also suggested that India should be cautious in developing cooperation with European nations in Africa because of their colonial rule. Panelists also noted that India’s Africa policy should be de-continentalised because of the diversity in Africa. ■



## Moving Ahead with Bilateral Dialogues

### India-Kenya Bilateral Technical Session on Co-WIN

GDC made a presentation on India's digital vaccination platform, Co-WIN with the support of GOI's National Health Authority, MoHFW to participants from Ministry of Health in Kenya to explore the possibility of its possible replication by the Kenyan Government.

Earlier, GDC had organised webinar on 'Coping with COVID: Experiences of developing countries in vaccine platforms and rollout' on May 19, 2021. The event was attended by health officials from Uganda, Rwanda, Kenya and Nigeria. Subsequently, GDC was constantly pursuing with relevant health officials from these countries to explore opportunities for possible adoption of Co-WIN platform or upgrading their existing vaccination platforms in lines of Co-WIN.

The main objective of organizing the presentation was to open avenues for possible upgrading and/or providing need based appropriate



solutions to Kenya through India's substantial experience, expertise and capabilities in this field.

The technical session held on 27 October 2021 was well appreciated by senior officials from Ministry of Health, Kenya and respective technical team members from Kenya. One of the technical official from Kenya informed

about several advancements their country has attained in developing it's digital vaccination platform. In line with GDC's mandate to curate and promote development experiences in Global South, Principal Secretary, Ministry of Health, Kenya was approached to share details of their vaccination platform. ■

## Development Cooperation

### The Palgrave Handbook of Development Cooperation for Achieving the 2030 Agenda

On the occasion of launch of 'The Palgrave Handbook of Development Cooperation for Achieving the 2030 Agenda,' a panel discussion was organised by NeST, RIS on 26 October 2021. The panel included editors of the handbook Professor Li Xiaoyun, CAU; Dr Stephan Klingebiel, DIE; Professor Sachin Chaturvedi, RIS. Dr Jurgen Karl Zattler, German Federal Ministry for Economic Cooperation and Development and Dr Haley Swedlund, Radboud University. The panel was moderated by Mr Artemy Izmetstiev, UNOSSC, Istanbul with concluding remarks by Professor Milindo Chakrabarti, Visiting Fellow, RIS.

The editors of the handbook highlighted the importance and relevance of the book for practitioners in developing countries. Development cooperation need to be taken ahead to collectively achieve the Agenda 2030. The discussants pointed out the importance of

### India-EU Connectivity: Partnership for Development, Demand and Democracy

The India-European Union (EU) Connectivity Partnership will be a vital component of the EU's Global Gateway initiative that aims to create 'links and not dependencies' through investments in quality infrastructure in order to connect goods, services, institutions, banks, businesses and people across the world, according to Ugo Astuto, Ambassador, Delegation of the European Union to India and Bhutan.

Launching a report by the RIS titled '*India-EU Connectivity: Partnership for Development, Demand and Democracy*,' on 28 October 2021, Ambassador Astuto also said leveraging the strengths of the European Investment Bank and the private sector will be key to effective implementation of the India-EU Connectivity Partnership.

Speaking at the event organised by the RIS, Mr Sandeep Chakravorty, Joint Secretary (Europe West), Ministry of External Affairs, said India and the EU have ensured that their bilateral Connectivity Partnership was of a 'high standard' and focuses on people-to-people connectivity as well as mobility. The bilateral Partnership has spurred similar ideas in other countries and regions for reasons including the importance of forging 'secure and trusted' supply chains, he added. Mr Chakravorty said there is a plan to launch an India-EU 'Connectivity Forum' soon to take forward viable projects in this context.

Ambassador (Dr) Mohan Kumar, Chairman, RIS, highlighted the strategic importance of the India-EU Connectivity Partnership and stressed the need to

expedite negotiations on India-EU trade and investment pacts to ably support the implementation of the bilateral connectivity agreement. Professor Sachin Chaturvedi, Director General, RIS, said the RIS report has an in-depth coverage and analysis of India-EU trade and investment, areas of cooperation in connectivity as well as ways to use connectivity for sustainable development and green transition by leveraging Science, Technology and Innovation (STI). He said the report also looks at alternative energy resources such as green hydrogen, solar and other kinds of non-conventional energy, in addition to financial connectivity from the institutional perspective where linkages between financial institutions, banks and providers of fintech have been examined in detail.



During the subsequent panel discussion, Ms Bhaswati Mukherjee, former Ambassador of India to the Netherlands, pointed out the

convergence between India and the EU on connectivity principles including on sustainability. She said the partnership agreement will be able to address the emerging challenges including that of financial and environmental sustainability. Professor Gulshan Sachdeva, Chairperson, Centre for European Studies, Jawaharlal Nehru University, said the India-EU Connectivity Partnership has huge potential and geo-political value with regard to enhancing connectivity in third countries as well, and will be an alternative to the Belt and Road Initiative of China.

Dr Constantino Xavier, Fellow, Centre for Social and Economic Progress, said since the bilateral connectivity partnership is based on democratic principles and lays emphasis on interoperability, in addition to transparency and good governance, it could help set regional standards and even help in the formation of a global connectivity partnership. Another important aspect was the decision of India and the EU to ensure that they, at a governmental level, will lead and facilitate, but not play an overwhelming role.

Professor S. K. Mohanty, RIS, mentioned that technology intensive trade is at the core of India-EU trade, while there are complementarities in their bilateral services trade. Speaking about the trends in development finance, Dr Priyadarshi Dash, Associate Professor, RIS, said there is now a focus on ESG (Environmental, Social, and Governance) norms. He observed that there was a need for greater financial connectivity between India and the EU in order to help both the sides achieve their full potential including on fintech. ■

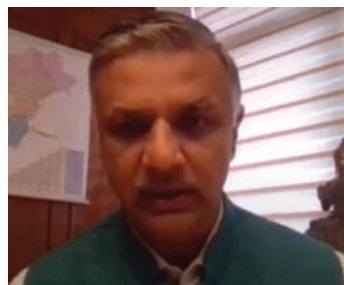
## Exploring Cooperation in Sustainable Agriculture and Value Addition in BIMSTEC Region



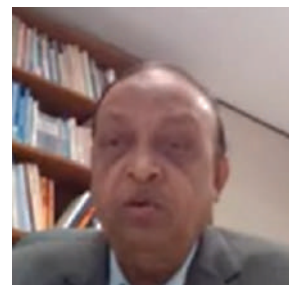

On 28 October 2021, RIS organized a webinar in association with International Food Policy Research Institute (IFPRI) on “Exploring Cooperation in Sustainable Agriculture and Value Addition in BIMSTEC Region”, where distinguished speakers, chairs, and panelists participated from the member states.

The webinar was inaugurated with the welcome remarks of Prof. Sachin Chaturvedi, Director General, RIS. He highlighted several important points on capacity building and collaborative work of the member states, expanding the development frontiers in the region, identifying the investment opportunities, and several others. Dr Suresh Babu, Senior Research Fellow & Head of Capacity Strengthening, IFPRI, Washington gave his opening remarks pointing out the importance of the priority alignment in the region. He further mentioned how a sustainable food system is the most important link in achieving the SDG goals and directly or indirectly affects nine out of seventeen SDGs.

The inaugural address was given by Professor Satish Y. Deodhar, Professor, Economics Area, Indian Institute of Management, Ahmedabad. He talked about the impact of climate change on food security, the need for a nudge in

connectivity, promotion of going vocal for local, weather forecast, value chains, knowledge sharing, and also highlighted the problem of lopsided production in agriculture.

After the inaugural session, there were three sessions. The first technical session was on ‘Promoting Trade in Agriculture in BIMSTEC’ where the chair and the panelists highlighted that agriculture in the region is highly vulnerable to climate change, hence, there is a risk on food security and value chain disruptions. Several suggestions were also made like increasing labor productivity and produce quality, promoting fair trade practices, food safety regulations, focusing on regional trade, etc.

The second technical session was on ‘Prospects of Food Processing and Regional Value Chains in BIMSTEC’ suggesting addressing and overcoming the bottlenecks, higher involvement of farmers in the value chains, improving the packaging at farm level, higher regional performance in various processed food sub-sectors, value chain upgrading, efficient use of data and improved data collection, etc. The third session on ‘Food Security and Safety Issues in Agriculture’ pointed out to focus on the nexus between agriculture and nutrition, to diversify the

produce, to spend on reducing the food loss and waste, to focus on private sector participation, etc.

The programme ended with a closing session chaired by Dr Suresh Babu, key recommendations were presented by Dr Priyadarshi Dash, Associate Professor, RIS. Valedictory address was given by Mr Han Thein Kyaw, Director-in-Charge (Agricultural Cooperation), BIMSTEC Secretariat, Dhaka, Bangladesh. Dr Amit Kumar, Assistant Professor, RIS, New Delhi gave vote of thanks. ■

## BIMSTEC: A Vehicle for Growth and Development

An interesting Symposium on “BIMSTEC: A Vehicle for Growth and Development” took place on 25-26 October 2021. It was organized jointly by the Institute of Social and Cultural Studies (ISCS), Kolkata, and RIS. In the inaugural session, Prof. Sachin Chaturvedi, Director General, RIS, gave welcome remarks wherein he talked about the transport connectivity in the region, digital and people-to-people connectivity, the importance of traditional medicines, and harnessing the potential of Regional Development Banks to facilitate the connectivity. Mr. Arindam Mukherjee, Director, ISCS, India spoke about focusing on counter-terrorism, energy, technology, climate change, disaster management, trade, and maritime cooperation.

Special address was delivered by H.E. Amb. Tenzin Lekphell, Secretary-General, BIMSTEC, in which he emphasised on the master plan for connectivity in the BIMSTEC region and for identifying transnational organized crime, maritime connectivity, illicit activities such as drug trafficking, and security as the areas for cooperation. He also highlighted the role of the BIMSTEC Energy Centre in India and the BIMSTEC Charter.

H. E. Amb. Harsh Vardhan Shringla, Foreign Secretary, Ministry of External Affairs, India gave the inaugural address making several valuable suggestions on the regional cooperation in cross-border movement of goods, energy, electricity (power grid connectivity), trade, coastal security, maritime connectivity, counter-terrorism, and tourism.

The two-day symposium had four technical sessions. The first technical session was on “Post COVID Economic Recovery and restoring growth momentum in BIMSTEC” in which many important



points were discussed. Panelists suggested incorporating the third space (civil societies and businesses) in the cooperation, discussing and narrowing down the common interest of the member states and bringing out through BIMSTEC as a platform, focusing on sustainable growth, investing in the healthcare sector, and developing health insurance system, investing in green recovery, and improving female labor force participation. Importance of blue economy, renewable energy, knowledge sharing, and best practices were also discussed in the session.

In the second technical session “Strengthening Regional Value Chains-Role of Connectivity and Trade Facilitation”, speakers suggested regional investment liberalization, promotion of SEZs in the member states, more connectivity projects like BBIM. In the session, speakers also mentioned how discontinuity of SAARC Summits gives and window of opportunity to BIMSTEC to come out more prominently as a cooperation platform in South Asia.

The third technical session was on “Regional Cooperation in Public Health Infrastructure and Health Care Services”. In this session speakers discussed how pandemic has highlighted the importance

of regional cooperation for both, during public health emergencies and normal circumstances. It was suggested to enhance the surveillance and information dissemination, to use ICT in medicine, to address mental health concerns, to increase government health expenditure as to reduce the out-of-pocket expenditure of the residents on health, knowledge sharing, and explore traditional medicine in the region. In the special address of the session, cyber security and related threats were also discussed by Lt. Gen. Rajesh Parth, National Cyber Security Coordinator, India.

In the fourth and the last technical session was on “Disaster Management, Maritime Cooperation, and Coastal Security”. Points flagged by the speakers included piracy, human and drug trafficking, pollution control, disaster management, blue economy, development of databases, networking, information sharing, and capacity building. Maritime cooperation was especially stressed up as the coastline of the region is very large and the Bay of Bengal is a very important link for the member countries.

The symposium ended with a valedictory session chaired by Amb. Sumith Nakandala, Executive Director of Indo-Lankan Studies, Path Finder Foundations, Sri Lanka (Former Secretary-General, BIMSTEC). Ambassador Dr. Anupam Ray, Joint Secretary, PP&R Division, Ministry of External Affairs, Govt of India gave special remarks. Dr. Suranjan Das, Vice-Chancellor, Jadavpur University, India participated as a distinguished speaker, and Dr. Priyadarshi Dash, Assistant Professor, RIS, India made a presentation on the symposium report. Mr. Krishndu Baksi, Programme Coordinator, ISCS, India gave vote of thanks. ■

economies will have to think for themselves about what is right for them rather than looking at advanced economies for inspiration, adding that there is a need to strengthen BRICS cooperation for supporting the intra-BRICS economic recovery. Effective usage of technology and mobilization of collective strengths are crucial to generate growth dividends and an orderly economic recovery, Dr Subramanian said. BRICS countries will be enhancing cooperation on financial regulation, especially in the context of cryptocurrency, as well as on the 'BRICS Bond Fund' to develop, integrate and deepen the bond markets in BRICS economies, he added.

Professor Sachin Chaturvedi, Director General, RIS, stressed

India's idea of creating human-centric digital global public goods architecture through the vaccination platform- CoWIN as well through the Jan Dhan-Aadhaar-Mobile (JAM), trinity or the bank account, digital identity and mobile phone-based digital transactions can now be made use of by the Global South as it works on economic recovery as well as to achieve the SDGs. He underlined that BRICS countries should enhance cooperation in areas such as green finance, green hydrogen and FinTech as they focus on economic recovery and address developmental challenges.

Professor Yarygina Irina, Department of International Finance, MGIMO University, Russia, Professor Haihong Gao,

Professor and Director, Research Center for International Finance, Institute of World Economics and Politics, Chinese Academy of Social Sciences (CASS), and Professor Manmohan Agarwal, Adjunct Senior Fellow, RIS, also spoke on the occasion.

Apart from the above RIS also organised following programmes: Innovative Financing Partnership with Africa; Maritime Security Cooperation (MSC); Indian Perspectives on Innovation Incentives: Health Impact Fund; Building Climate Ready Communities; Science, Technology and Innovation (STI) for Sustainable Development Goals (SDGs); and Future Strategies for SIDS and Climate Change. ■



## Review of ASEAN-India FTA: Identifying the Potentials and Challenges for Deepening India-Indonesia Economic Engagement

The ASEAN-India Centre at RIS and Embassy of Indonesia jointly organised a panel discussion on ASEAN-India FTA to identify the potentials and challenges for deepening India-Indonesia economic engagement on 29 November 2021 in virtual format. Mr Masni Eriza, Deputy Chief of Mission, Indonesian Embassy in Delhi; and Mr Vishvas Vidu Sapkal, Jt. Secretary (South and Indo-Pacific), MEA delivered the inaugural addresses. ### “Developing GVCs in India: Scaling up Taiwan’s Investment to India”

The COVID-19 pandemic exposed the vulnerability of global value chains (GVC) that compels the high labour force needs of industries, such as manufacturing industries to cease production. The effect of the epidemic was aggravated during phases of lockdown which induced recession across industrial sectors. This is even more harmful to developing countries, such as India whose GDP contracted by 7.3 per cent in 2020-21 as per the government estimates while the world grew by -3.41 per cent. Therefore, it is a considerable issue to further identify the sectors and possible physical zones of GVCs along with the increase of vaccine coverage and economic recovery.

Based on the long Supply Chains Collaboration of India and Taiwan on electronic components and products, the webinar on “Developing GVCs in India: Scaling up Taiwan’s Investment to India,” that took place on 9 December 2021 focussed primarily on the issue of Electronics, ICTs, and Semi-conductor sectors. The topics included (1) Taiwan’s Experiences in Developing electronics and semi-conductors supply chains; (2) India’s Visions and Current Developments of Electronics, ICT sectors, and Semi-Conductors industries; (3) India-Taiwan collaboration in technology industry supply chains – governments’ roles and business perspectives. This will deepen the

understanding between India and Taiwan on the technology and supply chain cooperation to deal with the U.S.-China trade war, COVID-19 pandemic and global economic turmoil. The increase in interaction between India and Taiwan, and the two countries becoming close trade partners in the future, would be beneficial for both sides.

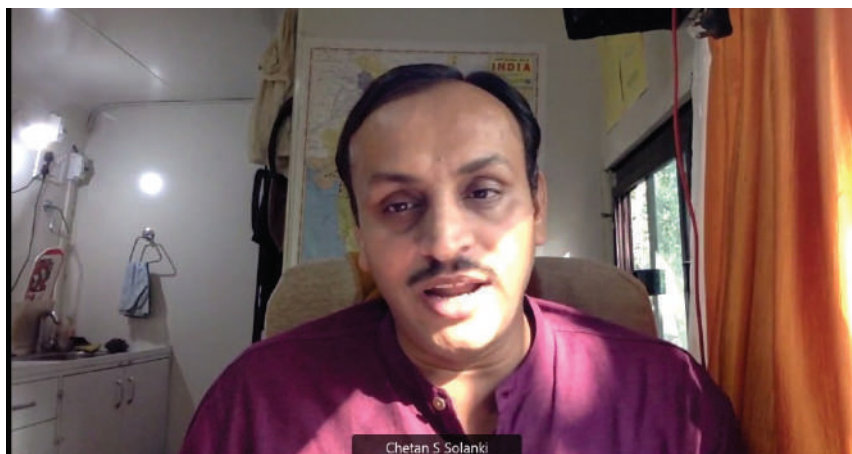

## 39th STIP Forum Lecture

The 39th STIP Forum Lecture was delivered by Professor Chetan Singh Solanki, Professor at the Department of Energy Science and Engineering, IIT Bombay, Founder of Energy Swaraj Foundation and the Brand Ambassador of Solar Energy for the state of Madhya Pradesh, on 22 December 2021 via online platform. The topic of this public lecture was “Realising Energy Swarajya in India through Solar: Towards Ensuring Energy Security and Climate Change Mitigation”. The event was chaired by Amb. (Dr.) Bhaskar Balakrishnan, Science Diplomacy Fellow, RIS. Dr. Krishna Ravi Srinivas delivered the welcome remarks, followed by brief remarks by Dr. Vibha Dhawan, DG, TERI and Mr. Sunit Tandon, Director, India Habitat Centre.

In his very insightful and thought-provoking address, Prof. Chetan S Solanki presented an overview of the prevailing alarming state in terms of the increasing pollution and climate change phenomenon, which is going to adversely impact the human species and threaten its sustenance in this planet. He exhorted that the decisive factor in this alarming state is the huge generation and usage of energy, derived from fossil fuels i.e. oil, gas and coal. Today 80-85 per cent of energy consumption is from fossil fuels, which are carbon-based; and when they are burned to generate energy, they use oxygen from the atmosphere and generate carbon-dioxide (CO<sub>2</sub>). CO<sub>2</sub> stays in the atmosphere for almost 300 years and being a Green House Gas (GHGs), it is leading to the global warming

of the planet, which will be catastrophic, if not checked now. Irresponsible human activities in the last thirty years have led to the excessive concentration of CO<sub>2</sub> in the atmosphere, which now stands at a dangerous level of about 415 ppm.

Prof. Solanki alluded to the dichotomy between growth and climate change and argued that while increase in energy supply is needed for growth; decrease in the energy supply is required for addressing the serious issue of climate change. Thus the key challenge is how to balance the growth without affecting the climate change. He argued for deploying drastic and immediate measures to deal with this alarming situation. Towards such a solution, Prof. Solanki urged for switching to 100 per cent solar energy immediately (wherever it's possible) and become Atma Nirbhar and adopt energy swarajya. He placed forward the twin principles of “Limited Consumption” and “Localised Production” as key to realise energy swarajya. He further went on to enumerate the benefits of energy swarajya such

as livelihood creation, energy independence, community involvement, strengthening of local and rural economy, energy discipline, energy security and sustainability.

At the end, Prof. Solanki advocated a three-step approach for everyone to follow to achieve energy swarajya and mitigate climate change. First step is to avoid use of energy as much as possible (even if it's solar) by trying to avoid at least by one-third. Second step is to minimize the use of energy as much as possible by practicing discipline and using efficient appliances and try to minimize at least by one-third; and the third step is to generate as little as possible (if possible, only one-third, that too locally!). He argued that this principle or rule of “AMG” (Avoid, Minimize and Generate) is critical for mitigating climate change and achieve energy swarajya. Finally, he appealed for making energy swarajya as public movement, as government actions alone won't be sufficient to address the challenge of such an enormous proportion. ■

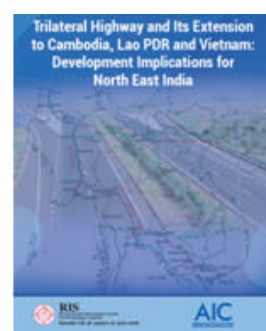
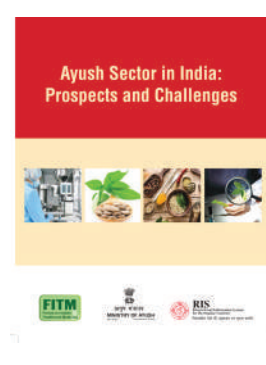
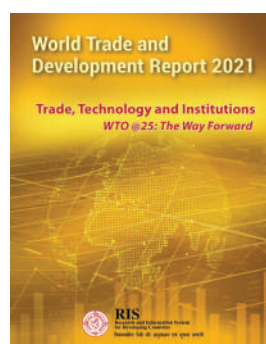
