G20 University Connect: Engaging Young Minds

India assumed G20 Presidency for 2023 on 1 December 2022. As the world continues to grapple with the post-COVID-19 wounds and fresh infections of new variants amidst uncertain and prolonged economic recovery, Indian Presidency of G20 holds significance for the Global South. The theme of the Indian Presidency i.e. 'One Earth, One Family, One Future' built on the all-encompassing civilisational value of "Vasudhaiva Kutumbakam" epitomizes that spirit. In that perspective, Hon'ble Prime Minister Narendra Modi has stressed on the public outreach and participation of all stakeholders (Jan Bhagidari) in the G20 process during the presidency. In that perspective, RIS has been tasked by the Ministry of

External Affairs to spread awareness among the students and the youth

under the G20 university connect series by organising 75 lectures on G20 issues at 75 universities across different states and union territories of India.

As part of this initiative, a curtain raiser event was organised in hybrid

mode by RIS in collaboration with MEA on 1 December, 2022 at Sushma Swaraj Bhawan, Ministry of External Affairs. More than 300 students had attended the event in person whereas around 1000 were connected virtually. In

addition, the Vice Chancellors and the faculty representatives of all the 75 universities attended the event. The event was graced by Shri Dr S. Jaishankar, Hon'ble External Affairs Minister who passionately shared rich diplomatic experience with the students in his valedictory address and subsequently in the interaction session.

Dr P.K. Mishra, Principal Secretary to the Prime Minister delivered the keynote address. Dr Mishra emphasized that the lecture series could prepare future leaders and help create capacity for providing inputs into multilateral process like G20 in the future besides stressing the critical role of Jan Bhagidari. He also stressed on the emerging opportunities for the countries like India to leverage upon.

An interactive meeting on G20 priorities of India was hosted by Global Development Centre at RIS on 29 November 2022. The key participants include Mr Adam Taylor, Head of Economics and Finance; Mr Abhirup Dasgupta, Head of Economic Cooperation Programmes; Ms Aditi Banerjee, Economic Adviser, British High Commission (BHC). The event was also attended by several eminent experts including Dr Rajat Kathuria, Dean, School of Humanities & Social Sciences, Shiv Nadar University; Mr Arvind Gupta, Head & Co-Founder, Digital India Foundation; and Mr Pranav Kumar, Vice President, Reliance Industries Limited and RIS faculty members.

The meeting concluded that while setting the G20 priorities for Indian Presidency, the following key areas needs attention:

- Cooperation in multiple fronts to prioritise peace and security agenda
- Pandemic preparedness and affordable access to vaccines
- Promotion of Green Technologies
- Climate change and
- Promotion of broader concept of Lifestyle for Environment (LiFE). ■

G20 India Presidency and Global Economic Order: Trade, Investment and Technology

RIS in collaboration with T20 and Indian Economic Association organised a special session on G20 on the theme “G20 India Presidency and Global Economic order” at the 105th Annual Conference of the Indian Economic Association at CMS Business School, JAIN University, Bengaluru on 27 December, 2022. Professor Sachin Chaturvedi, Director General, RIS delivered the Special Address on “Indian Presidency and Development Agenda of G20: Broad Reflections”. He stressed on the key dimensions of emerging development paradigm

such as climate change, SDGs, local context, LiFE, etc and the possible contribution of Indian Presidency. Dr Priyadarshi Dash, Associate Professor, moderated the panel discussion. The panelists were Professor S.K. Mohanty, Professor, RIS; Professor N. Bhanumurthy, Vice Chancellor, Dr B.R. Ambedkar School of Economics University, Bangalore; Mr G.A. Tadas, Former Executive Director, IDBI and Professor Amitabh Kundu, Senior Fellow, World Resources Institute, New Delhi. Professor Mohanty made a comprehensive presentation

on trends in global trade and investment flows and the positions of the G20 countries especially the developing countries.

Professor Kundu covered the social sector issues in G20 which increasingly assume presidency in G20 deliberations. He highlighted the pervasive income inequality among the G20 countries and the importance of health and education for the success of G20 Indian Presidency. Mr Tadas made an extensive presentation on SDGs. Besides emphasizing

Bharatiya Developmental Approach and Role of Civil Society Organizations



On the occasion of India's G20 Presidency, RIS jointly with Maharshi Karve Stree Shikshan Sanstha, Pune; YOJAK, Center for Research and Strategic Planning for Sustainable Development, Pune; Rambhau Mhalagi Prabodhini, Mumbai; Vivekananda Kendra Kanyakumari; and Sewa International organised a day-long conference titled "G20 Presidency

of Bharat: Bharatiya Developmental Approach and Role of Civil Society Organizations" on 14 November 2022 to discuss the issues before the Civil 20 (C20), which is an official Engagement Group under the G20 process.

The meeting was convened in preparation towards India's G20 Presidency. Considering the global developmental issues, the meeting

was aimed at exploring the subject areas that India should assertively put forth, and what should be the appropriate framework and terminologies. Key questions include the nature of programmes that should be taken up in the paradigm of development and those subject matters related to development that should be the areas of priority during India's G20 Presidency.

Therein, what should be the role of CSOs in developmental paradigm and going beyond continuous deliberations, research and discussions; and institutional arrangements that may be needed for this purpose? Finally, how can Indian CSO's help in devising indigenous solutions for problems in developing world, starting from identifying problems, understanding local experiences and

know-how to search for solutions, partnering with local CSO's in other countries as a way ahead.

The conference was addressed by Dr Vinay Sahasrabuddhe, President, Indian Council for Cultural Relations; Professor Sachin Chaturvedi, Director General, RIS; Shri Ravindra Sathe, Director General, Rambhau Mhalagi Prabodhini; Smt. Nivedita Bhide, Vice President, Vivekananda Kendra Kanyakumari; Shri

Ravindra Deo, Chairman, Maharshi Karve Stree Shikshan Sanstha; Shri Shyam Parande; International Coordinator, Sewa International; Dr Gajanan Dange, President, YOJAK, Center for Research and Strategic Planning for Sustainable Development; and Professor Vivek Kumar, Coordinator, Unnat Bharat Abhiyaan, IIT Delhi; and several other prominent leaders, researchers and senior functionaries of civil society organisations from India.

The key outcome of the meeting was centred around exploring and appreciating the relevance of grassroots initiatives connected to human-centric development, sustainable lifestyles, sustainable agriculture and rejuvenation of the nature drawing on traditional knowledge systems and culture, and presenting them as solutions to contemporary global challenges. Hence, G20 leaders need to be appraised of the potential of local solutions, sustainable practices and transformative paradigms that have been part of civilisational legacy, community knowledge and societal behaviour as a way forward and rally international support behind them.

Participating institutions shared their experiences in these regard including notable initiatives in various parts of India. Convergence of traditional systems and modern approaches including science and innovation remains the key to overcoming shortcomings of technology centric production systems and unsustainable consumption patterns. India's own knowledge base in this regard is extremely rich and hence India's Presidency of the G20 would be a golden opportunity to highlight India's contributions and leadership. ■

on the progress made on SDGs in developing countries and the associated challenges in meeting it by 2030, he indicated the possible financing options available to the developing countries in the post-Covid era. Professor Bhanumurthy touched upon the monetary and

fiscal policy challenges faced by the developing countries during the pandemic and the roadmap that G20 could follow in fostering cooperation among the G20 countries with a proper policy mix of fiscal consolidation, managing high inflation and monetary policy

choices. Dr Dash presented the growing development financing gap in the post-Covid years, in particular in infrastructure sectors. He also referred to the possible areas of reforms by G20 to help mobilise resources for bridging this financing gap. ■

Exploring Options for G20 Wellbeing Metrics

RIS organised a workshop on “Exploring Options for G20 Wellbeing Metrics” on 23 November 2022. It was attended by OECD and RIS teams (in-person and virtual mode) and participants were experts from other International Organisations (IOs) and Academia. Presentations were made by both OECD and RIS teams. The key highlights of the workshop are as under:

- The world has moved far from simple measures of per capita income to new indicators of development like Human Development Index (HDI) or the Multidimensional Vulnerability Index (MVI), propounded by the UNDP. The *World Happiness Report*, by the Sustainable Development Solutions Network, shows how people evaluate their own lives. The OECD ‘Framework for Measuring Well-Being and Progress’ has launched Better Life Index to capture well-being. The RIS has also attempted in the past to develop Wellness index and dashboards within the BRICS countries. These are examples of measures that go beyond pure economic indicators and touch upon social, educational, health, mental health, life satisfaction outcomes, reflecting that measuring development is not only a matter of income level

but also of individual and societal wellbeing.

- The G20 deliberations over the years have shifted more towards sustainable development priorities. In recognition of the need to move towards sustainable development, G20 in 2015 adopted Addis Ababa Action Agenda (AAAA) on financing for development, supporting SDGs to be achieved by 2030. The G20 has regularly deliberated and reviewed progress in SDGs. The SDG 17.19 demands for initiatives to develop such a measure of wellbeing to complement GDP.
- With COVID pandemic and geopolitical conflicts since 2020, the G20 has been grappling with new challenges of sustaining livelihoods, health care, supply chain disruptions, food security, unequal burden on LDCs, inequality in growth across countries. These developments have necessitated the need for comprehensive discussion on multidimensional nature of development and should reflect heterogeneities in terms of development, technological advancement, poverty and inequality, gender, disparities, culture, lifestyles etc.
- It would be desirable to review, compare and assess existing work in the domain of wellbeing metrics

and identify the gaps that need to be filled in existing multidimensional frameworks, especially after COVID-19 pandemic.

- Choice of indicators should be based on data availability, consistency and comparability, input indicators vs. output indicators depending upon end use. This should also take into account in capacity building requirements in infrastructure and skills for handling data in many developing countries, especially LDCs.
- The Wellbeing metrics should factor country specific characteristics, focus on a few core aspects of development and easy for public to understand. We may develop dash boards that can be used for informing policymaking, budgetary planning, capturing returns on investments and informing international allocation of resources.
- G20 Wellbeing metrics needs to be relevant to the G20 framework and what is agreeable among G20 members, and should have synergy with work program towards SDGs. Thus, the designing of a G20 Wellbeing metrics requires wide ranging issues to be discussed and agreed upon. The proposal to evolve a G20 Wellbeing metrics may also be with DWG. ■

STI for SDGs Roadmaps

RIS and Office of the Principal Scientific Adviser to the Government of India joined organised “The Workshop on Science, Technology and Innovation for Sustainable Development Goals” on 11 October 2022 at New Delhi. The Inaugural Session initiated with the welcome remarks by Professor Sachin Chaturvedi, where he presented the context of the workshop and highlighted the key contours of India’s STI for SDG Roadmaps. Professor Chaturvedi, Director General, RIS also presented the draft report mentioned that the report has highlighted the roadmaps and approaches needed for mainstreaming STI for SDGs in our development thinking, particularly challenges related to the key focused SDG goals of zero hunger (SDG 2), health and well-being (SDG 3), water and sanitation (SDG 6), and affordable and clean energy (SDG 7) and also emphasized the focus

should be placed on affordable technology in order to lower the cost of adoption, which may then be shared through UN procedures.

In his special remarks, Mr Shombi Sharp, underscores the importance of the upcoming G-20 presidency of India that can open up new avenues for the sharing of information and technology. He also pointed out the need to guarantee that we yield technology in a way that reduces the digital divide, the difference between nations, and even the gender barrier.

Ms Eriko Yamazaki, highlighted the role Japan has played in International cooperation and collaboration between various sectors, such as the government, corporate, and social sectors, that are critical to achieving the STI for SDGs.

Mr Hemang Jani, stressed that STI for SDGs will be critical not only for India and the six pilot countries, but also for creating a roadmap

for the entire global community. He also put forward views on the present developmental challenges that necessitate a technological perspective, such as employing drones to better map agricultural land and build solutions, or delivering medicines not only as a logistical challenge but also to secure last-mile delivery through technology.

In his Inaugural Address, Professor Ajay Kumar Sood, Principal Scientific Advisor to the Government of India, stated that science, technology, and innovation were identified as critical means of attaining the SDGs in the 2030 Agenda for Sustainable Development. Digital public goods have been used in national projects, such as the National Mission on Sustainable Agriculture and Poshan Abhiyaan, to ensure food security. Similarly, PSA highlighted the

eminent universities on 6 October 2022 at New Delhi.

At the outset, Ambassador Dr Mohan Kumar, Chairman, RIS delivered the welcome remarks and the session was chaired by Ambassador Amar Sinha, Distinguished Fellow at RIS. The special address was given by H. E. Ms Elizabeth Mary Spehar, Assistant Secretary General for Peace Building Support, Department of Political and Peace Building Affairs (DPPA), United Nations. The distinguished panel includes H. E. Ms Bintou Keita, Special Representative and Head of the United Nations' Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO), Mr Shombi Sharp, UN Resident Coordinator in India, Ambassador Bhaskar Balakrishnan, Science Diplomacy Fellow at RIS, Ambassador Vijay K. Nambiar, Professor Milindo Chakrabarti, O. P. Jindal Global University, Professor Sreeram Chaulia, Dean at Jindal

highlighted the linkage between peace and development and the significance of this nexus to confront current global challenges. H. E. Ms Elizabeth Mary addressed SDGs as the blueprint of common vision of society which has positive approach on peace. She underscored the importance of linkages between peace and development. She also discussed the issues related to food security, climate change and environment, war in Ukraine and COVID-19. She highlighted the need of peace building architecture, gender responsive and inclusive approach of development and the requirement of avenues for youngsters to abstain them from indulging in illegal activities.

H. E. Ms Bintou Keita talked about the significance of peace and development at global perspective with the example of Democratic Republic of Congo and said that development of a country is not possible until the peace and harmony

production and responsible consumption is highly ignored in the global context. Professor Shreeram Chaulia discussed the geo-political situations and the debt crisis fueled by China. The panelist also highlighted the future potential for south- south and triangular cooperation in support of peace and development.

Basically, the panel discussion touched upon the linkages between peace and development and the reason behind this nexus to be considered critical to confronting today's global challenges. Further it seeks to explore the potential for South-South and triangular cooperation in support of peace and development.

The panel discussion was followed by a Students' Interactive Session of H. E. Ms Elizabeth with a group of graduate and post graduate students from the Department of Conflict Analysis and Peace-building of the Nelson Mandela Centre for

Curtain Raiser to 19th ASEAN-India Summit

The year 2022 marks 30 years of formal engagement between ASEAN and India. The relations between them have elevated to comprehensive strategic partnership level in 2022. ASEAN and India had the 19th ASEAN-India Summit (commemorative summit) in Phnom Penh, Cambodia on 12-13 November 2022. Prior to the Summit, the ASEAN-India Centre (AIC) at RIS and Cambodian Institute for Cooperation and Peace (CICP) jointly organised a curtain raiser in Phnom Penh on 4 November, 2022 to ponder on the ways to strengthen ASEAN-India cooperation in the post pandemic.

The curtain raiser started with the welcome remarks by Amb. Pou Sothirak, Executive Director, CICP and Dr. Prabir De, Professor and Coordinator, ASEAN-India Centre (AIC) at RIS. Highlighting civilisational links between India and ASEAN, both of them welcomed the participants and

introduced the background of the curtain raiser. Delivering special remarks, H.E. Robert Matheus Michael Tene, Deputy Secretary General of ASEAN for Political Security Community hailed the mutual cooperation between India and ASEAN during the COVID-19 pandemic period. He argued that India and ASEAN should focus on practical opportunities to strengthen the relationship and identified financial and physical connectivity,

people to people contacts, cyber security and vocational education as promising areas for cooperation. Delivering the inaugural address, H.E. Saurabh Kumar, Secretary (East), Ministry of External Affairs (MEA), Government of India underscored the importance of economic issues that constitute the core of India-ASEAN relations. Apart from stressing on the importance of physical, digital and financial connectivity, he also pointed out the need for cooperation in the field of science and technology. Delivering the keynote address, H.E. Kung Phoak, Secretary of State, Ministry of Foreign Affairs and International Cooperation, Cambodia highlighted the commonalities between the ASEAN Comprehensive Economic Recovery Framework, ASEAN Outlook on the Indo-Pacific (AOIP) and Indo-Pacific Oceans Initiative (IPOI). H.E. Kung Phoak identified digital economy, public health

Besides, he cited the case of 6Ps (people, planet, peace, partnership, promotion, prosperity) while scaling up the ASEAN-India relations. In her special remarks, Ms. Meloney Lindberg, Country Representative, The Asia Foundation (TAF), Cambodia highlighted the engagement of TAF with the think-tanks in India and ASEAN. Relationship has grown step by step in the last thirty years and she called for greater cooperation between India and ASEAN to deal with new challenges.

India-Bhutan Economic Relations

An Interactive Session with Journalists/Editors from Media Organisations of Bhutan was organised at RIS on 22 November 2022. The programme began with introductory remarks delivered by Professor S. K. Mohanty, RIS and Professor T. C. James, Visiting Fellow, RIS. Following the introductory remarks, Professor

Mohanty made a presentation on India-Bhutan Bilateral Economic Relations. Prof. Mohanty talked about the key features of India-Bhutan bilateral trade relations and highlighted the areas of potential growth. This was followed by a presentation by Professor T. C. James. The focus of Prof James's talk was wellness. In his talk, Dr R.

V. Shahi, Distinguished Fellow, RIS highlighted the importance and key aspects of South Asia Power Grid. The next presentation was made by Dr Priyadarshi Dash, Associate Professor, RIS. The focus of Dr Dash deliberation was Financial Inclusion- Lessons from India and other developing countries. ■

46th STIP Forum Lecture

The 46th STIP Forum Lecture was delivered by Dr Bhaskar Balakrishnan, Former Ambassador of India and Science Diplomacy Fellow, RIS on 30 December 2022 via online platform. The topic of this public lecture was *"Emerging Treaty for the High Seas and Marine Biodiversity"*. Welcome remarks were delivered by Dr Amit Kumar, Assistant Professor, RIS, followed by remarks by Mr Sunit Tandon, Director, India Habitat Centre.

Dr Balakrishnan began his very insightful address by highlighting the significance and value of marine biodiversity for nature, economy and livelihoods. He stated that oceans provide the world with goods and services worth at least USD 2.2 Tn (in terms of Blue Economy) and about 3 billion people depend on oceanic products such as fish for their livelihood and primary source of dietary protein. He further stated that due to the rising adverse impact of pollution, plastics and climate change, there is an imperative to protect marine biodiversity and marine habitats. There are serious concerns about the increasing

anthropogenic pressures posed by existing and emerging activities, such as fishing, mining, marine pollution, and bioprospecting in the deep sea. He mentioned that UNCLOS does not refer expressly to marine biodiversity, but it is regarded as establishing the legal framework for all activities in the ocean. Convention on Biological Diversity (CBD), which entered into force in 1993, defines biodiversity and aims to promote its conservation. In areas beyond national jurisdiction (ABNJ), the Convention applies to processes and activities carried out under the jurisdiction or control of its parties.

Dr Balakrishnan highlighted that a new international agreement for the conservation and sustainable use of biodiversity is emerging (High Seas Treaty or BBNJ agreement) as the UN's Intergovernmental Conference on Marine Biodiversity of Areas Beyond National Jurisdiction, covering 61 percent of the ocean. In this regard, Indian delegation comprises officials from the Ministry of Earth Sciences (MoES), Centre for Marine Fisheries and Research Institute and the Ministry of External Affairs. The MoES is the nodal Ministry tasked with coordinating India's position on the forthcoming agreement. India's draft Blue Economy framework, released Sept 2020. Blue Economy policy is yet to be finalised.

In his concluding statements, Dr Balakrishnan highlighted India's position, wherein, Prime Minister Shri Narendra Modi at the One Ocean Summit in February 2022 stated that *"India supports the French initiative of a High Ambition Coalition on Bio-diversity Beyond National Jurisdiction....we hope for a legally binding international treaty this year"*. ■

PM-STIAC proposed 'One Health Mission,' which will integrate disease surveillance and control in India's wildlife, livestock, and human systems. In the area of sanitation, he mentioned the customised amphibious excavator for cleaning urban drains clogged with mixed solid waste, including construction and demolition trash that can help local governments manage and regulate sanitation systems.

He also touched upon India's

commitment towards South-South Cooperation under which India has created technology such as an oil extraction system, a soil organic carbon detection kit, and an ergonomically designed treadle pump which have been implemented by Namibia, Zambia, Sudan, and Ghana. Some measures of state governments, such as Gujarat's Wind Policy (2016), Maharashtra's Unconventional Energy Generation Policy (2020), and Karnataka's Renewable Energy Policy (2022),

were critical in meeting our energy targets. Sustainable financing mechanisms, such as the Smart Cities Mission and NABARD's Green Financing, were mentioned that will be critical for the development of STI for the SDGs.

Later three Sessions pertaining to STI for SDGs were unfold following by the Valedictory Session was chaired by Professor Sachin Chaturvedi, Director General, RIS. ■

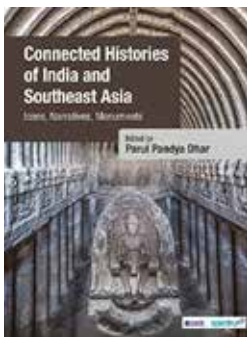

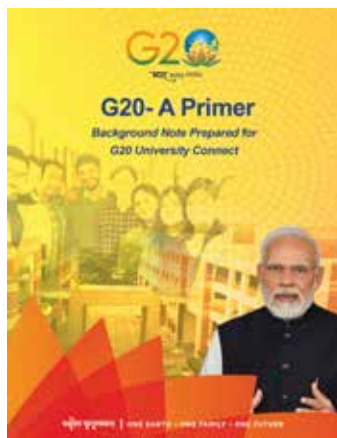
